Also present were Ms. Carolyn Mooney, Chancery Clerk and Clerk of the Board of Supervisors, Mr. Mike Sumrall, County Administrator, and Mr. Rick Barlow, Board Attorney.

Mr. Ray Boswell, President of the Board of Supervisors, called the August recessed meeting to order.
