Legal descriptions and maps have been made available to the public to inspect in the Circuit Clerk's Office. Chairman of the Lauderdale County Election Commission, Jeff Tate, came before the board to discuss reasons for each change in voting precinct boundaries and polling place locations.

After further discussion and no objections to these changes, a motion by Supervisor Kyle Rutledge, seconded by Supervisor Wayman Newell, to close the Public Hearing, was passed unanimously.
