For Written Sealed Bids:

- Envelopes containing the bids must be sealed, addressed to “The Lauderdale County Board of Supervisors”, 410 Constitution Ave, 11th Floor, Meridian, MS 39301 and should contain the bidder’s name and mailing address, the bid number and name of the bid item.
- If any envelope is not so marked, any bid contained therein will not be considered.
- Paper/written hand delivered bids shall be submitted in separate sealed envelope addressed to “The Lauderdale County Board of Supervisors” and should contain the bidder’s name and mailing address, the bid number and name of the bid item.

For Electronic Bids:

- When submitting an electronic bid, the bid must be submitted in “pdf” format and shall contain the same information and forms as required for the paper bids. When submitting a bid electronically, the authorized signature shall be an electronic signature or handwritten in blue-ink signature. In the event that an electronically submitted bid has a corrupted attachment, the bid will be considered null and void.
