### **1. CORRECTED & AMENDED BID FORMS:**

#### **1. BID FORM - OPTION #2 – Revision/Correction on Page 11.**

- a. The form contained a descriptive error. The language was changed from roll-off to dumpster.
- b. *A revised/corrected proposal form to replace Page 11 has been issued and included in this addendum.*

#### **2. ADDITIONAL INFORMATION QUESTIONNAIRE – Amended on Page 7.**

- a. Additional questions, Items (2) & (7), have been added to the form.
- b. *An amended questionnaire to replace Page 7 has been issued and included in this addendum.*

### **2. SUBMITTED QUESTIONS CLARIFICATIONS & RESPONSES:**

#### **CLARIFICATIONS:**

- 1. RE: Page 4, 1<sup>st</sup> Paragraph: Relating to number of containers and service/frequency changes. The frequency set forth in this proposal is an estimation based on current services. Regarding the specified dates of service, adjustments may be required to match the needs of the County.

#### **RESPONSES:**

- 1. Will the County expect the contractor to service the scheduled roll offs every day of the defined service schedule regardless of how full the roll offs are? *The frequency included in this proposal is an estimation based on current services. Regarding the specified date, adjustment may be required to match the needs of the County. It is not necessary to dump the roll off if it is low/or not full. In such instances a service/surcharge fee can be assessed. Please include your specified surcharge rate in the Amended Additional Information Questionnaire on Page 7, Item (7).*

2. Will the designated disposal site be Pine Ridge Landfill on Murphy Road? **No. The disposal site will be at the discretion of the Vendor to direct to the lowest and best price.**
3. Will it be up to the contractor's discretion on which disposal location will be used? **Yes. However, Lauderdale County reserves the right to select the most cost-effective option.**
4. Can the contractor use multiple disposal sites throughout the contract at their discretion, or does there need to be one disposal site selected for all waste throughout the contract? **While one (1) site is preferred, should you have intentions of using multiple disposal sites that information should be disclosed in the proposal along with the disposal site name and per ton rate(s).**
5. Item 2 in Addendum 1 mentions that the disposal cost will be paid by the County. Will those costs be paid by the County directly to the disposal facility, or will the vendor be required to incur those costs and seek reimbursement from the County? **The County will pay the cost directly to the disposal facility.**
6. Should question number one on page 7 of the proposal documents be deleted since the County will be paying for disposal? **No. This is information the County would like to have included.**
7. The first paragraph of Section (F) Disposal Site, mentions that "Contractor shall provide a disposal site at its own expense." Is the contractor required to own/operate the disposal site, or can the contractor use a disposal site that is owned by a third party? **The disposal site expense will be incurred by the County, and was addressed in Addendum 1, Item (2). No, the contractor is not required to own/operate the disposal site. A third-party disposal site can be utilized.**
8. Will the County expect a copy of the contractor's proposed service agreement terms to be submitted along with the bid proposal? **Yes, please include with your proposal.**
9. Who is the current provider of these services? **Waste Pro, formerly JWC.**
10. Is the county waste from these services currently going to Pine Ridge landfill? **Yes.** If so, how is the tonnage for front-load services determined? **I cannot attest to how the current vendor determines this. However, the general determination is based on the weight of the waste material placed in the dumpster, typically measured in tons.**
11. Should proposers offer proposed rates including disposal for front load services, or for haul only with the County paying disposal at Pine Ridge based on a pre-determined tonnage per container haul? **Proposers should propose rates as defined on the proposal form to include monthly rental charge for dumpsters and the associated cost per front load pull, to include hauling. There is no pre-determined tonnage, only the actual weight of the container at the time of disposal, which the County pays directly to the specified disposal site of the Vendor awarded the bid.**
